  - Create and Architect Liaison Team composed of the following recommended members: Amanda Elias, Jan Hicks, Kathleen Kane, Steve Layton, Mark Neumann, Diane Schoenrock, Stephen Shaver
    - Stephen asks Vestry's permission to ask Alan Bolchazy if Mark Neumann is unable to join team
  - 2. Authorize the Architect Liaison Team to expend up to \$12,500 from the Capital Campaign Fund for ongoing consulting fees for Jim Heid
  - Authorize the Capital Campaign Fundraising Team to expend up to \$12,500 from the Capital Campaign Fund for consulting fees from a capital campaign professional of the team's choosing
  - 4. A. Authorize the Architect Liaison Team to select an architectural firm and enter into contract with them for the conceptual and schematic design work that will create a project proposal with cost estimates for our capital campaign, and to expend up to \$100,000 from the Capital Campaign Fund for this first phase of work;

Or

B. Request that the Architect Liaison Team enter into discussions with one or more architectural firms and bring a recommended contract proposal back to the Vestry for its approval at a future meeting (probably in December).

Items 1, 2, 3, and 4b Motioned: Bill, Seconded: Mark (with amendment to add Alan Bolchazy as an alternate if he cannot accept position), Approved Unanimously
